RULES AND REGULATIONS FOR THE USE OF HINDU MANDIR FACILITIES

1. Everyone must comply with all posted rules and regulations within the building and on the grounds of the Mandir, such as No Parking signs, no photography, food or drink, no socializing or carrying on conversations in the Mandir Sanctum Sanctorum.
2. Must maintain the sanctity of the Mandir at all times.
3. Observe the parking regulations as they impact on the New York State building and fire code requirement and are a condition of our building occupancy permit. **NO PARKING ALLOWED ON THE DRIVEWAY OR THE GRASS.** Please park in the rear parking lot.
4. Alcohol, tobacco and meat in any form are not allowed on the premises, including the building and the grounds, at any time.
5. No commercial vendors or exhibitions are allowed on the grounds without prior written permission.
6. All terms and conditions of the contract for use of the facilities must be adhered to and the facility be used for the stated purpose only. Subcontracting is prohibited and will render your contract null and void. You may not be able to use the facilities for holding your events in future.
7. At the conclusion of the event, please broom or dry mop all floors. All trash should be deposited in the Dumpster and the Dumpster kept shut.
8. All chairs and tables shall be picked up and stacked against the chair rail (underside of the seat facing toward you) and stacked on the Table Cart, respectively.
9. There should not be any dragging of chairs and tables on the floor.
10. The kitchen is only for light cooking and warm-up. No commercial cooking is allowed in the kitchen.
11. All spillages should be immediately wiped dry.
12. It is the responsibility of the host / user of the Mandir facility to make certain that their guests observe the above Rules and Regulations.
